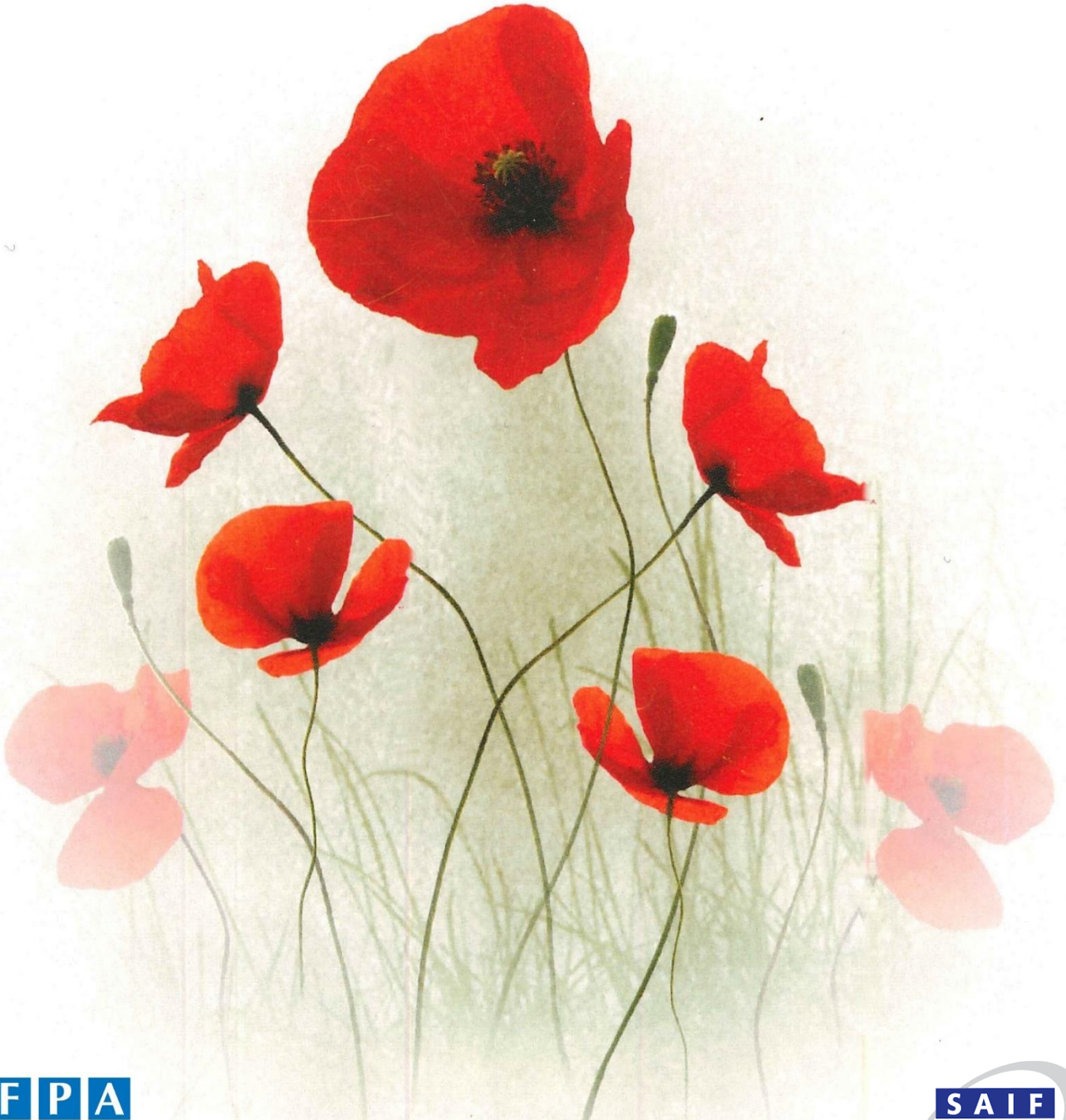

DIRECT TO CREMATORY OR BURIAL SERVICE

Direct to Crematory or Burial is a practical, lower cost alternative offered by us to answer the specific requests of families who choose the most simple, dignified and economical means of arranging their loved one's departure. In recent years we have seen an increase in interest in this option, which is often the wishes of the deceased themselves. The deceased is cremated or buried, at a date and time of our choosing, without any service or attendance at the crematorium or cemetery (this option is not available for churchyards). **You can rest assured that your loved one will receive our usual level of respect and dignity throughout, including the use of our hearse, bearers and full ceremonial clothing.** A memorial service can be arranged by yourself, if desired, at a time, date and location most convenient and most fitting to you.

TERMS OF SETTLEMENT: *Applicable from 1st July 2019*

In addition to our charges, disbursements must be paid to Doctors, Ministers of Religion, Celebrants, Cremation or Cemetery fees and such like. After the funeral arrangements have been discussed, you will be required to pay a deposit of cleared funds, within 5 working days of the funeral arrangements taking place, and this will be calculated on the type of funeral arrangements discussed. You will then be sent a written estimate of all the charges incurred, in line with the service you have requested. Where the total estimated account is deemed excessive, you may be asked to make a further interim payment. **We need to draw to your attention that, failure to pay the deposit within the given timeframe, will result in the cancellation of all funeral arrangements.** The balance of the account will be required as laid out in the following paragraph.

By accepting our Terms & Conditions, you consent that you accept the charges and will be liable for payment of the final account when submitted. This is usually 1 week after the funeral and it is expected for payment to be made within 30 days (excluding Direct or Burial / Cremation which will be required to be paid in advance). You also accept that if no payment or contact has been made within 60 days of the funeral, the account will be forwarded to a 3rd party debt recovery company and additional recovery/legal costs will be incurred. If wished, the account may be forwarded to a solicitor or bank. If, because of your circumstances, you have to make a claim for assistance from the Department of Work and Pensions, please note that stringent rules apply as to the amount of help available. Please talk to us, in confidence, for guidance.

[Right to cancel](#)

You have the right to cancel the contract if you wish. This right can be exercised by sending or taking a cancellation notice to the funeral director at any time, within the period of 14 days starting on the day of the arrangements. The right to cancel, can be lost during the cancellation period, if the service is provided in full before the 14 days elapses.

Where applicable, payment will be required to be made in respect of any services carried out or disbursements paid, once the performance of the contract has begun and prior to the cancellation notice being received.
